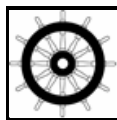

  - RHZK 6/30, steel (Volume 6 l, capacity 1800 l),
  - RHZKF 6.8/30, composite (Volume 6.8 l, capacity 2040 l).

Maximum working pressure 30MPa.

## Application/Limitation

Approved for use as self-contained compressed air breathing apparatus of fire-fighter's outfit.

The apparatus is not for use in accidents with cargoes.

All air cylinders for breathing apparatus shall be interchangeable.

A set of manufacturer's instructions shall accompany every unit and should be kept onboard. Manufacturer's instructions for application / limitations, checks prior to use, donning and fitting, use, cleaning and disinfection, maintenance, transport and storage shall be adhered to.
